Delivery: Beginning August 1st, 2024, and continue through July 31st, 2025, American Crystal will deliver the Byproducts to Buyer by loading the Byproducts into Buyer’s vehicle at the applicable factory location as further described in the Terms and Conditions. Unless Buyer can establish to American Crystal’s satisfaction that a greater load weight is legally permitted, American Crystal will load a maximum of 50,000lbs into Buyer’s vehicle. American Crystal reserves the right to load less than 50,000lbs if American Crystal determines that Buyer’s truck cannot handle such volume. Requests and documentation to support a greater load weight must be submitted in writing.
